Subject: Regarding transfer of Rs. 24,790 from Sabha Nidhi (Gram Panchayat Fund) in the bank account of Kaushal Vikas Nigam for training of Nal Jal Mitra.

Sir/Madam,

As you are aware that one Nal Jal Mitra from each Gram Panchayat is to be trained for operation and maintenance of piped water supply schemes being implemented in the rural areas through Gram Panchayats. These Nal Jal Mitra will work under the overall supervision and control of the Gram Panchayats.

All Gram Panchayats in the State were directed to make a provision of Rs. 24,790 in supplementary GPDP under 15<sup>th</sup> Finance Commission Tied Grant for the year 2023-24 and to provide the same to the bank account of Kaushal Vikas Nigam as training cost. The State has not received the tied grants for the year 2023-24 and this amount could not be transferred to HPKVN so far. This fund cannot be provided from the unspent amount of the previous financial years because there is no activity to book this expenditure in the previous years. Therefore, the Govt. has decided that this training cost of Rs. 24,790 will be transferred to HPKVN from Sabha Nidhi (Gram Panchayat Fund).

You are therefore requested to direct all Gram Panchayats under your jurisdiction to transfer Rs. 24,790 from Sabha Nidhi/Gram Panchayat Fund in the bank account of HPKVN (Account No. 37927395118, IFSC SBIN0014639, Bank Branch Kasumpti). All payments should be made by 25<sup>th</sup> June, 2024. Gram Panchayats which have already made full payments to HPKVN on account of training of Nal Jal Mitra need not make the payment again. However, those Gram Panchayats which have made partial payment earlier shall make balance payment. The information regarding the payment be shared in the Google Sheet (enclosed) by 30<sup>th</sup> June positively.
