ORDER

WHEREAS, the Block Development Officer, Solan, District Solan (H.P.) has requested to transfer the Government land comprised in **Khasra No. 131/112/1 measuring 01-0 Bigha, situated at mauja Nehar, Tehsil & District Solan (H.P.) in favour of Rural Development Department for construction of Shamshanghat.**

AND WHEREAS, Sub Divisional Officer (Civil), Solan, District Solan (H.P.) in his report has also recommended to transfer the above mentioned land in favour of **Rural Development Department**. The proposed land is in the ownership of Government of H.P. The NOCs of Jal Shakti Vibhag, Forest, HPSEBL, and HPPWD have also been received in this regard.

Therefore, exercising the power vested in me vide letter No Rev-D(G)6-24/91 dated 9-7-1991 and subsequent order No Rev-D (G)8-14/2015 dated 9-2-2016 and clarification No. Rev-D (G) 8-9/2021 dated 30-3-2022, I, Manmohan Sharma (I.A.S) District Collector, Solan District, do hereby order to transfer the Government land comprised **Khasra No. 131/112/1 measuring 01-0 Bigha, situated at mauja Nehar, Tehsil & District Solan (H.P.) in favour of Rural Development Department for construction of Shamshanghat**, subject to the final outcome of the SLP (civil) No 13393/2008 filed in the Hon'ble Supreme Court of India against the order dated 22-11-2007 passed by Hon'ble High Court of H.P in CWP No 1077/2006 titled as Khatri Ram v/s State of H.P. If the said department does not use the land for the purpose for which it is being transferred within two years, then this land shall be reverted to the Department of Revenue free from all encumbrances. It is also directed that no excavation or mining work will be carried out on the transferred land without the prior approval of SDM concerned.
