Three members to be nominated by Gram Panchayat Resolution with the following constitution; one BPL from SC category, one BPL from OBC category and one BPL from General category, provided that at least one of these shall be a women and destitute personal or persons with disability; provided further that in the Tribal areas, one BPL of ST category, shall be selected instead of SC category.

In case the Pradhan of the Gram Panchayat is unavailable or is prevented from performing his/her duties as such, the meeting shall be chaired by the concerned elected member of Panchaya Samiti. In case there is more than one Mahila Mandal or Yuvak Mandal in the Gram Panchayat, on of them shall be nonmasted by a resolution of the Gram Panchayat.

The Fair Price Shop Level Vigilance Committee shall perform the following functions:-:

1. Regularly supervise the implementation of all schemes under National Food Security Act; 2013.

2. Inform the District Grievance Redressal Officer, in writing, of any violation of the provisions of this Act; and

3) Inform the District Grievance Redressal Officer, in writing, of any malpractice or misappropriation of funds found by it.
