**Subject: Regarding conducting of quarterly Vigilance Committee meeting at FPS level.**

On the foregoing subject it is informed that the National Food Security Act, 2013 is being implemented in the State w.e.f. 1<sup>st</sup> October, 2013. As per provision of Section 29 (1) of the Act, every State Government shall set up Vigilance Committees for ensuring transparency and proper functioning of TPDS in the District. For the purpose State Govt. has notified the FPS level Vigilance Committee and its functioning vide Notification No. FDS.F(6)3/2010 dated 20-11-2013 (Copy attached). As per provision laid down in the notification, this meeting shall be held at least once in a quarter.

In view of the above, it is requested to direct the Panchayat Secretary/Sahayak to conduct quarterly Vigilance Committee meeting as per provision of the Act *ibid*, so that proper transparency and smooth functioning of TPDS could be ensured in the District please.

The Government of Himachal Pradesh for ensuring transparency and proper functioning of Targeted Public Distribution System in the State and in compliance of the section 29 (1) of the National Food Security Act, 2013 is pleased to constitute the Fair Price Shop Level Vigilance Committee in Rural Areas with immediate effect consisting of the following members:-

In case the Pradhan of the Gram Panchayat is unavailable or is prevented from performing his/her duties as such, the meeting shall be chaired by the concerned elected member of Panchayat Samiti. In case there is more than one Mahila Mandal or Yuvak Mandal in the Gram Panchayat, one of them shall be nominated by a resolution of the Gram Panchayat.

The Fair Price Shop Level Vigilance Committee shall perform the following functions:-

1. Regularly supervise the implementation of all schemes under National Food Security Act, 2013.
  2. Inform the District Grievance Redressal Officer, in writing, of any violation of the provisions of this Act; and
  3. Inform the District Grievance Redressal Officer, in writing, of any malpractice or misappropriation of funds found by it.
- The Committee shall meet at least once in a quarter.
