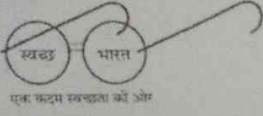


1. Creation of community compost pit for group of households and o and maintenance of Community Compost Pits.


