NOTIFICATION

On the recommendation of Committee constituted for framing the scheme for providing relief and rehabilitation to the people affected by the flash floods, cloud burst and landslides in the various district of Himachal Pradesh from 07.07.2023 to 15.07.2023, the Governor, Himachal Pradesh is pleased to notify the "Special norms for relief and rehabilitation from rain, flood and landslide damages in July 2023" as under:-


Special norms for relief and rehabilitation from rain, flood and landslide damages in July 2023:

Applicability:

These norms will be applicable to damages sustained from rain, flood and landslide between 7th July to 15th July, 2013. The Deputy Commissioner shall certify which areas have sustained such damages, and shall process these cases in only such areas.

Benefits as immediate relief:

SN	Type of damage	Amount	Process of verification
1	Partial House damage (kutcha or pucca)	Rs. 1,00,000	Patwari report.
2	Shops and dhabas	Rs. 1,00,000	Patwari report.
3	Belongings of tenants	Rs. 50,000	Patwari report. May take report of Panchayat Secretary of Gram Panchayat.
4	Desilting of agricultural and horticultural land	Rs. 5,000 per bigha	Patwari report.
5	Land loss of agricultural and horticultural land	Rs. 10,000 per bigha	Patwari report.
6	Crop damage	Rs. 2,000 per bigha	Patwari report.
7	Large milch and draught animal	Rs. 1,00,000 per animal	Patwari report. Also reports of Panchayat Secretary of Gram Panchayat and Animal Husbandry Department.
8	Goat, pig, sheep and	Rs 10,000	Patwari report. Also reports of Panchayat Secretary of Gram



Process of sanctioning:

The patwari shall prepare the NakshaQuaif (as per format given in HP Land Records Manual, 1993) of every damage and submit it to Field Kanungo, who will verify each damage case by visiting the site of damage.

The Field Kanungo will submit it to the Tehsildar/Naib Tehsildar for further necessary action. Final sanction shall be given by SDO (C) upon receipt of recommendation from Tehsildar/Naib Tehsildar.

Process of funding:

Where any item is reimbursable as per HP DM and Relief Manual, 2012, and its norms, as updated from time to time, the payment shall be made from HP SDRF. Additional amount, if any, shall be paid from additional funds to be provided by the Govt. of HP for this purpose.

The relief and rehabilitation activities will be carried out as per the above norms by the Deputy Commissioner concerned strictly following the process of sanctioning as mentioned above.
