In partial modification of this department Notification of number FDS-A(3)02/2009 dated 01-08-2013 notifying the Rajiv Gandhi Anna Yojana guidelines for identification of priority households under the National Food Security Act, 2013, the Governor, Himachal Pradesh, is pleased to amend/revise the categories of persons for inclusion in the list of Eligible Households, with immediate effect, as under:-

- Following categories of persons shall be automatically included in the list of Eligible
- All families indentified as AAY beneficiaries in the State as per the updated lists 1. approved during the Gram Sabha meetings.
- All families, identified as Below Poverty Line households (BPL) and households for subsidized rations at BPL rates and are not already covered under AAY scheme as per the updated lists approved by the respective Gram Panchayats during the 3.
- Households with any member receiving pensions from Department of Social Empowerment like old age pension, widow pension, disabled pension, lepers and pension. 4.
- Households with a beneficiary under Annapurna Anna Yojana scheme. 5.
- All Tibetans or refugee who are verified by Tibetan Settlement Officer.

In case of a situation, where a households name figures in more than one category, the name of the household shall be considered once.

- Inclusion/Exclusion criteria for left out households: B.
- 1. Inclusion criteria:

The households in a Local Body shall be included in the list in the following order of Aikal Naris.

- 1)
- Orphans, abandoned children and those residing in Ahrams. ii) iii)
- Household headed by a widow.
- Household with any member having more than 60% disability duly iv) certified by medical board.
- Households headed by terminally ill person. V)
- Households headed by person of sixty years of age or more with no vi) . assured means of subsistence or social support.

- Households headed by a person registered as construction worker under vii) the provisions of the Building and other construction workers (Regulation of employment and conditions of servie) Act, 1996. viii)
- Households who have completed 50 mandays of work under MGNREGA in ix)
- Person with any kind of disability.
- X) Household of Patients of Leprosy, HIV and Cancer.
- Household of War Widows and families of Freedom Fighters. xi)
- All inmates, who are living in Asharams (Vridhasharam & Bal Ashram etc.), Nari xii) Niketans, Hostels for orphans/destitute, Tibetan Children Village Schools (Viz. at Dharamshal Cantt., Lower Dharamashala,, Suja/Bir Mandi and Chauntra in Mandi) but are not being provided any assistance in cash or kind for their food security by State/Central Government.

In addition to these, additional upto 10% of the population not covered so far under NFSA as per criteria of 56.23% for rural and 30.99% for urban areas in each Gram Panchayat/Urban Body may be selected as beneficiaries by giving priority to the poorest out of the left out/un-covered persons subject to the

- Should not belong to household having more than 5 Hectares of non-irrigated land or 2 Hectare of irrigated land. 2)
- Should not belong to a household having average monthly income of more than Rs.12,000/- per month.

The condition of barring BPL Household of having Pucca Urban Type Big House shall not be applicable for selection of household under NFSA for this additional

Remaining conditions contained in the Notification dated 01-08-2013 would remain the same including the process of Selection of Household which may be undertaken again now in order to include the above categories for which Rural Development Department and Urban Development Department may take necessary action.
