5. स्थानीय सरकार और अन्य विभागों की सभी गतिविधियों में बाल केंद्रित दृष्टिकोण पर बातचीत करने में एक गतिशील शक्ति के रूप में कार्य करना ।

Sir,

Please find enclosed herewith photocopy of D.O. Letter No. M-11015/433/2020-Governance, dated 03-08-2021 from the Additional Secretary, GoI, MoPR, on the subject cited above. It has been mentioned in the letter that:-


1. The Constitution of India guarantees Fundamental Rights to all children in the country and empowers the State to make special provisions for children. The Directive Principles of State Policy specifically guide the State in securing the tender age of children from abuse and ensuring that children are given opportunities and facilities to develop in a healthy manner, in conditions of freedom and dignity. The State is responsible for ensuring that childhood is protected from exploitation, moral and material abandonment. Protecting the rights of the children and ensuring them access to all necessary entitlements and facilities is the duty of the governing bodies at local and national levels.
2. That the department should initiate concerted efforts towards establishing child-friendly Panchayats as a matter of practice. This would ensure that all duty-bearers of children's rights are able to progressively ensure that every child within their area of jurisdiction is fully able to enjoy their rights for survival, development, participation and protection among others. Child-friendly Panchayats would guarantee children's rights to all their rightful entitlements such as health, education, safe water, sanitation, protection from abuse and exploitation, etc. Duty-bearers must therefore initiate child sensitive development interventions through planning, budgeting and monitoring for children.
3. Alternatively, the Bal Panchayats and Bal Sabhas, as platforms for child participation in governance may be established at local level. The Bal Sabhas would work for all children in the Panchayat, irrespective of class, caste, gender or religion.
 - To provide children with a common platform to come together
 - To introduce children to the democratic process and Local Government system
 - To discuss developmental activities, needs and problems of children and to seek suggestions to solve the problems
 - To evaluate the activities of institutions working for children
 - To act as a dynamic force in negotiating a child centric approach in all the activities of local government and other departments

The recommendations of the Bal Panchayats, as vetted by the Gram Panchayat may be included in the annual Panchayat Development Plans (GPDPs) Additionally, the child centric committees in the Panchayats viz. Village Child Protection Committee, School welfare committees etc. would be required to be mobilised to actively engage in monitoring the status of the children in the village through consistent review of functioning of service delivery instructions, form a committee for inter-committee coordination at GP level for monitoring and consistent interaction with Bal Panchayats and Bal Sabhas.

Therefore, in view of the above, you are therefore, requested to direct all the Gram Panchayats under your jurisdiction to establish Bal Panchayats & Bal Sabhas as platform for child participation in governance & recommendation of the Bal Panchayats, as vetted by the Gram Panchayat may also be included in the Annual Panchayat Development Plans (GPDP's). The child centric committees in the Panchayats viz. Village Child Protection Committee; School welfare committees etc. will also be required to be mobilise to actively engage in monitoring the status of the children in the village through consistent review of functioning of service delivery institutions, form a committee for inter-committee coordination at GP level for monitoring and consistent interaction with Bal Panchayats and Bal Sabhas.
